Carbon Monoxide and Diesel Engines

Starting in 1998, the American Boat and Yacht Council Standards began requiring carbon monoxide (CO) detectors on boats with gasoline powered propulsion engines and/or generators. The statute doesn't apply to boats with diesel engines, which produce only about 10% of the CO of their gasoline counterparts.

While diesels are certainly far safer, there is at least one situation where a diesel powered boat could easily become surrounded by a deadly cloud of carbon monoxide - when it's rafted with other boats that are using gasoline generators. In that situation, CO from the exhaust of one boat could easily be pulled into the vent on another.

Certainly, any boat with a gasoline propulsion engine or generator, sleeping accommodations should have a CO detector installed in the sleeping compartment. But if you own a diesel-powered boat and raft-up with gasoline powered boats, it would be smart to also install a CO detector. The only safe alternative would be to anchor away from the raft-up before going to bed.

Life Jacket Proven to Save Lives

National Safe Boating Week for Florida started Sunday May 18th, and for good reasons since the state led the nation in boating fatalities in 2006. Florida recorded 69 fatalities in 2006 as well as 77 fatalities in 2007.

Brevard County ranked 9th among the top 10 Florida Counties for the number of boating accidents in 2007 and 8th out of 10 in 2006. Brevard recorded one fatal accident in 2007, seven accidents with injury and 15 without injury. The 2006 numbers were 4 fatalities, 12 accidents with injury and 9 without injury.

Monroe County ranked first in total accidents in 2007 and 2006. It recorded four fatal accidents in 2007, 27 accidents with injury and 43 without injury.

"The frequency of boating accidents in Florida would probably be a shock to most people," Lt. Ed Cates of the FWC's Division of Law Enforcement said in a press release. "The ultimate goal is to change accident trends and reduce the number of accidents, injuries and deaths on Florida waters."

Nationally, nearly half of the fatal accidents involved boats less than 16' such as open runabouts, personal watercraft, Jon boats and paddle-powered craft. U. S. Coast Guard statistics show of the 474 deaths in 2006 42 % (201) involved boats less than 16'. Statistics at www.wearitflorida.com said approximately three-quarters of the boats involved in accidents were less than 27'

BOATING SEASON KICKS OFF UNDER THREAT OF NEW EPA PERMIT PROGRAM

Solution Moves a Step Forward But Boaters Need to Speak Out Now

ALEXANDRIA VA, May 27, 2008 - With the Memorial Day traditional start of the recreational boating season now passed, you'd think the owners of this country's 18 million boats would be in good spirits.

However, under threat of a new, onerous and potentially costly EPA permit program to be in place by September 30 of this year, recreational boaters and anglers have only a short time to encourage their Senators and Representatives in Congress to support the "Clean Boating Act of 2008." The bill would retain a 35-year-old exemption under the Clean Water Act of 1972 for "normal operational" discharges from recreational boats, such as deck run-off from rain or engine cooling water.

The EPA has been required to develop the permit program as a result of a lawsuit originally intended to prevent the spread of invasive species from abroad by targeting ocean-going commercial vessels carrying ballast water. The proposed Clean Boating Act of 2008 does not weaken any existing environmental laws that restrict the overboard discharge of oil, fuel, garbage, or sewage.

The Senate version of the bill, S. 2766, moved out of the Senate Environment and Public Works Committee on May 21 following an identical House version, H.R. 5949, which moved out of the House Transportation and Infrastructure Committee on May 15. Both bills are now headed for full Senate and House votes, respectively, in the next few weeks.

"We have jumped over two huge hurdles in both the Senate and House Committees," said BoatU.S. Vice President of Government Affairs Margaret Podlich. "However, with only nine weeks left in the Congressional session before September, we are facing a tight timeline. Everyone who enjoys boating needs to ask their legislators for their support when it comes to a floor vote. We need constituents to speak up now - even if they have done so in the past year," she added.

BoatU.S. also said help is needed to convert the 93 House sponsors who had previously co-sponsored a similar House bill, H.R. 2550 - now dormant - to be co-sponsors of the newest version, H.R. 5949.

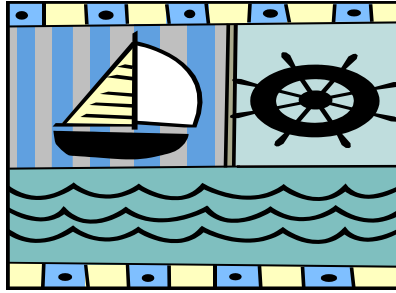
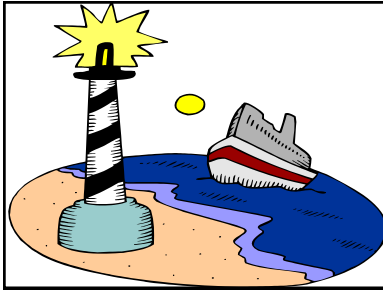

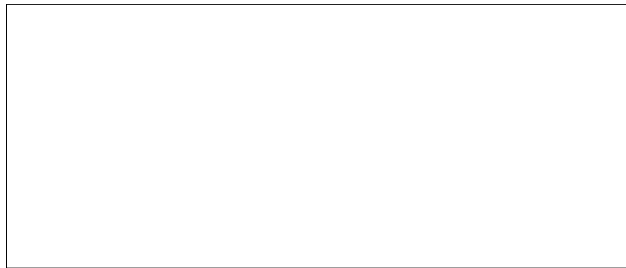
