The Executive Board passed a motion to adopt the Slogan “220 in 2020” as a goal for the squadron. We were over 220 members 10 years ago; we can be 220 in 2020.

The Squadron Education Department has met and agreed on a course outline for the next 18 months, with at least 4 ABC3 classes per year, each followed by either a Seamanship or Piloting class to involve the new members who pass ABC3. We will also offer more Elective courses. This will require more Instructors but we have enough classrooms and projectors.

To help with our new goal, the Executive Board decided to accept outsiders to all our Electives, Seamanship and Piloting courses at member cost + membership cost, thereby making them new members. All CBSPS courses are now published on the USPS HQ800 system. This has already registered 4 students for the July ABC3 course and 2 students for the Weather course.

5 N exams have been taken and are now being graded. Cruise Planning started with 6 students. Weather will start 10 Sept with at least 12 students and Seamanship will start 13 Sept 2012. For the first half of 2013, we have planned AP starting 7 January, P starting 17 January, Engine Maintenance starting 1 April and S starting 25 April. **Dues can be paid by check or on line by credit card.**

**The number one reason given by members for not paying their dues is that they forgot. That is why it is important that we have the Bridge or a committee call those who have not renewed their membership. What is sad is when no one knows the person that is to be called. That usually means that that member has not attended meetings, has not taken a class or attended social programs. Why do we allow this to happen? 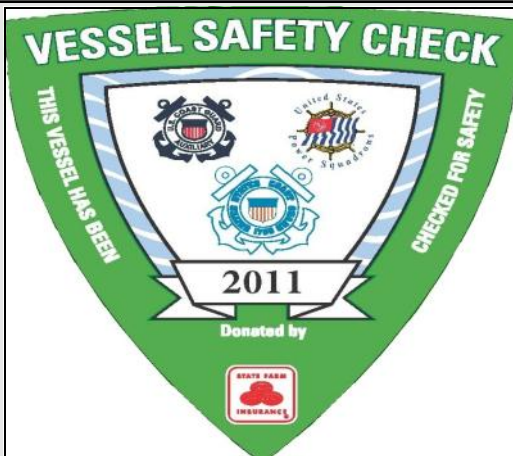
## **Boating Report by P/C Duane L. Balkema, AP**

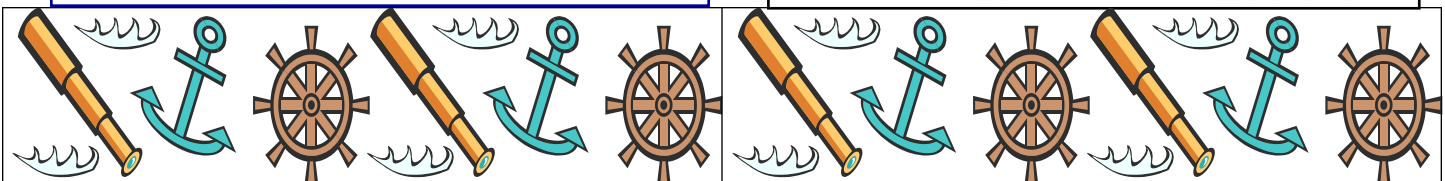
