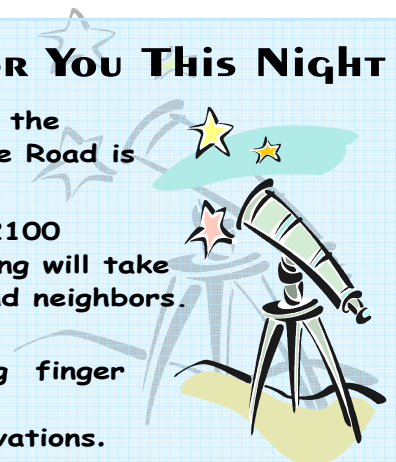
THE HEAVENS WILL ALIGHT FOR YOU THIS NIGHT

Peter Schmidt, the instructors, proctors, Coco-Nauts and others who participated did a marvelous job and we thank you! P/D/C Fred Adame, SN, distributed certificates to the four members who completed Operations Training. Present to receive were Lt. Peter Schmidt, P, and Lt/C John Mulkey, P. Peter Collette and Sylvia Smith were the others to complete the course.

Our Power Squadron is similar to most organizations in that it is made up of people. However, we happen to be a non-profit organization and the functions that we perform are done by volunteers! A further distinction is that we are dynamic and functioning continuously, not just holding a monthly meeting. People (the members) are our primary resource. Because of the non-profit status we can't reward those who volunteer their time monetarily as is done in a business organization. One way we do recognize and reward members who volunteer their time to squadron functions, or make significant contributions, is the Merit Mark. I would compare the Merit Mark to receiving a commendation or achievement award before I retired. It is a selective award based on significant contributions, time served and is awarded annually by the USPS National Headquarters. 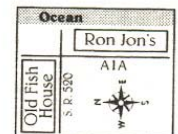

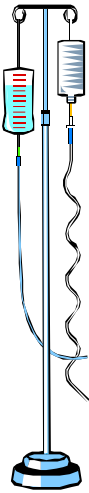

It may surprise you to know that red blood cells have a shelf life of only 42 days, and platelets have a shelf life of only 5 days. Therefore, it is important that the blood supply in our Blood Banks needs to be constantly replenished. Your donation is usually transferred to a patient within 72 hours. Please consider being a donor in our next Blood Drive. Our May 20th donation date may be past by the time you receive the Soundings. If so, mark July 14th (a Thursday) on your calendar and join the regular donors. It doesn't take long, is greatly needed, and is a way to earn a merit mark.

Government Recall Information For All Products Including Boats.

A recent issue of Boat U.S. states that the National Marine Manufacturers Association has collaborated with the Consumer Product Safety Commission to set up www.recalls.gov, as a clearing house Web site for government recall information of all types of products including boats. The U.S. Coast Guard's own web site at www.uscg-boating.org/recalls/recalls_database.htm is also available to check for recalls. Boat U.S. publishes new recalls on a monthly basis at www.BoatUS.com/recall.as they are issued by the Coast Guard.

Owners can also register their boat and engine information on the Boat.U.S. National Recall Alert Registry at this site. The secure database makes it possible for marine manufactures to locate owners in the event of a safety defect recall. The recall period for boats was extended from 5 years to 10 to allow owners adequate time to seek remedies when defects are found.

Here 's a little bit of good news. Thanks to boaters who threatened to boycott the Bahamas and from pressure from U.S. and Bahama boating industries, the Bahamian government has modified its fee structure which went into effect last July 1st. Effective last January boaters can now make 2 trips to the islands in a 90-day period for one permit fee. The new fee schedule came as a shock to many boaters.

The fees are: \$150 for boats up to 35 feet; and \$300 for boats over 35 feet.

- THE HISTORY OF THE USPS PORT CAPTAIN PROGRAM- PAST AND PRE-SENT-

The Port Captain program originated in the mind of P/C/C Bruce M. Steere, SN prior to his rise to the role of USPS Chief Commander in 1984. As a yachtsman who each year made the round trip between Palm Beach, FL and Harwich Port, MA aboard his 65 foot sailing yacht the Magic Carpet, he often thought of how nice it would be if USPS had a program to assist members. Likewise as a yachtsman who cruised extensively along the East Coast and the Bahamas, he could see how nice it would be to have member contacts throughout the US. His thoughts included giving assistance in various ways as they cruised around the USA, the Bahamas and elsewhere.

In 1985 the Port Captain program, under the newly established Boating Activities Committee, of which I was the first R/C, would include a roster of members from all squadrons published in a directory which would be available to all members. The members who volunteer are to offer information and assistance to members, and yes, friends of members, are listed in the directory by geographic location. For example in our area we have a member covering each of the following Port Canaveral, Indian River and the Banana River from lets say the NASA Causeway to Dragon Point. The type of assistance typically offered covers such things as where is a boat yard where I can get some engine work done or we have a leak which needs attention, where can I get in touch with a good dentist to fix a broken tooth, what is a good restaurant in Cocoa, I'm coming up from the Bahamas and need a marina to put my yacht up for the summer while we go north. And the list goes on and on. Other parts of the boating activities program included members volunteering to be crew members for boat moving, etc., and having squadrons and districts publish their cruising schedules in THE ENSIGN so members in other squadrons could join in the event to meet and socialize with other USPS members.

As a local Port Captain since setting up the program some 20 years ago, the program has evolved as USPS membership levels and interests have changed. Over the years I averaged about 2 to 3 calls each year for various reasons. The program still has about 800 members nation wide and the roster is now available only on line where it can be downloaded. While the cruising schedule is still being published in THE ENSIGN, the crew assistance program never quite took off **P/R/C Dick Schnoor, SN**

Gene Millner has had many rewarding experiences while helping others. He has been a Port Captain for over 15 years and plans to continue. With Barbara and Gene's location on the ICW, it is deemed only natural for him to hold this position. He's helped disabled boaters and provided dockage for the night while repairs were being made. Sometimes he's made trips to the gas station to buy fuel. One of the CBPS former members broke down near his pier and was able to drift in. That boat spent a week on the Millner lift before he was towed to a launch ramp.

Gene remembers the time he spotted an overturned sailboard with two people who could not get it righted. It was cold and getting dark. He called a passing boater on the VHF who backtracked several miles out of their way to rescue the boaters and bring them to his dock. They left their boat overnight and picked it up the next day. This young couple sent a beautiful plant to the Millners with a note expressing their gratitude. He's met many appreciative boaters while serving as Port Captain. Most of his experiences have been gratifying but there is one incident he just can't forget:

"Several years ago, I got a call from a boater staying at a marina about 12 miles away. He needed help and asked if I could assist. He and his wife had recently purchased a 48-foot trawler and were on their way from somewhere in the Carolinas for an extended cruise to the Bahamas. When plugging in to the shore power, the end of the 50-amp cable fell apart. Neither the marina nor any of the local supply houses had a replacement single 50-amp cable. It was a very hot day, and they were not looking forward to a night aboard without air conditioning. This is where I entered the story. They had found my name in the Port Captain Roster, told me of their plight, and asked for my assistance..

I suggested he contact a friend of mine who had a rather large yacht docked at that marina, as I thought he might be able to help. It should be noted that a new cable is approximately \$500. My friend was able to locate a new cable end (about \$75). He took it to his shop and attached the new cable end, and returned it to the distressed boater. This good Samaritan didn't charge a penny for his service, and saved him a considerable amount of money. The boaters were able to spend a comfortable night aboard thanks to his efforts.

The next day, I got another call from the same boater who requested additional help. I drove to the marina, took him to a hardware store to buy tools and to a grocery store for needed food supplies. Barbara and I were asked to join them for a dinner out that evening and to talk about cruising in the Bahamas. We were able to provide them with our cruising experiences while going over the Bahamas charts. After this we drove them to dinner at a very reasonably priced restaurant where we ate and paid for our own dinners. THOUGH NOT A FEDERAL HOLIDAY, FLAG DAY IS CELEBRATED JUNE 14TH

Flag Day recognizes the June day in 1777 when the Continental Congress adopted the "Stars and Stripes" as the official flag of the United States. In 1814, Francis Scott Key wrote a poem, "Defense of Fort McHenry," when he saw the flag still flying the morning after an attack by the British. Today, that poem is known by another name: "The Star-Spangled Banner."

The Flag Act of 1818 states that a star be added for any new state on the Fourth of July following that state's admission. Flag Day was observed for the first time in 1877, the 100th anniversary of the adoption of our country's red-white-and-blue banner.

Congress officially recognized Flag Day by passing the National Flag Day Bill in 1949, during President Harry Truman's administration. In 1983, the world's largest flag was displayed in Washington, D.C. The flag, which measured 411 feet by 210 feet, weighed 7 tons! Each star measured 13 feet across!.

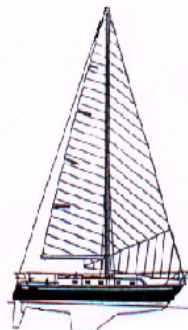

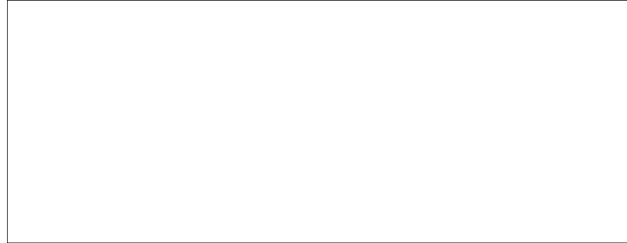
