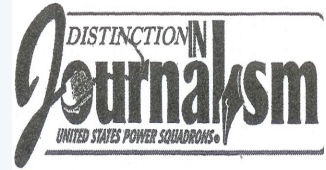

As you should already know, at the recently held USPS Annual Meeting, the majority of the squadrons voted to accept the new membership requirements for a three year trial period. This new procedure allows boaters to become members of the USPS without taking a Boating Course or passing a Boating Course final examination. Each squadron will have to vote to accept the new procedures or retain the old method. The CBPS Executive Board will meet in April to review the changes and make a recommendation to the general membership at the May General Membership Meeting. What would this mean to CBPS? The new procedures allow you to ask any of your boating friends to join the USPS without their sitting through a boating course or taking a boating exam. All they have to do is apply for membership, be approved by the Executive Board, pay their dues and they become members. The new procedures are designed to allow people who have some boating experience to take advantage of this new procedure. It allows you to talk to your fellow boating friends, and members of any other boating organization to join with us. The new procedures are in fact designed for boating people. It is still highly recommended that prospective members with no boating experience take our Boating course which we will offer as we have in the past. Of course, these experienced boating people can take this course if they so choose. Invite your boating friends to one of our general membership meetings, talk up the fact we are a group of dedicated boaters who are educationally oriented who at the same time have fun as members of CBPS. You will be an important means for getting new members and you will be providing a valuable service to your boating friends. The new procedure, if accepted, will only work if you, our members, get the word out! If we vote to follow the new procedure, this will be a perfect opportunity to increase our squadron's membership. Lt. Doris Valentine is our squadron Membership Chairperson and she will have the membership applications.

I attended the District 23 Spring Conference held in Altamonte Springs at the Holiday Inn. On Saturday afternoon, awards were presented. It was my great pleasure to make numerous trips to the podium to accept awards for Cocoa Beach Power Squadron and individual CBPS members.

- Liaison = Set in place the means to identify local points-of contacts, i.e., USCG, Law Enforcement, etc..
- Vessel Safety Examinations = Promote & offer free recognized inspections to ensure safety reqmt's are met.
- Radio Technical Committee = Determine how to facilitate action on radio/electronic matters for squadron.
- Legislative Committee = Determine the means to communicate boating legislative matters to the squadron.

**NORTH AMERICAN SAFE BOATING CAMPAIGN**

*How does National Safe Boating Week serve as a kick-off for boating season?*

National Safe Boating Week is a great way to kick off what will be a fun and safe summer on the water. From May 19th-25th we're asking boaters to pay EXTRA attention to their boating safety behaviors, and especially to ALWAYS wear their life jackets. Remember... even the most experienced boaters fall victim to boating accidents.

**What is the goal of National Safe Boating Week?**

The goal of National Safe Boating Week is to heighten awareness among recreational boaters of the importance about ALWAYS wearing a life jacket.

This includes informing boaters that they have options when it comes to today's modern life jackets. This includes new inflatable versions that offer a complete range of movement. There are even jackets customized for hunting, angling, and paddling, or high impact water-sports, such as water-skiing, wakeboarding, and riding jet skis. There are no excuses for not wearing one.

**Who produces this event?**

The North American Safe Boating Campaign is produced by the National Safe Boating Council in partnership with the National Association of State Boating Law Administrators in collaboration with the Canadian Safe Boating Council. The campaign is produced under a grant from the Sport Fish Restoration (Wallop-Breaux) Trust Fund administered by the U.S. Coast Guard.

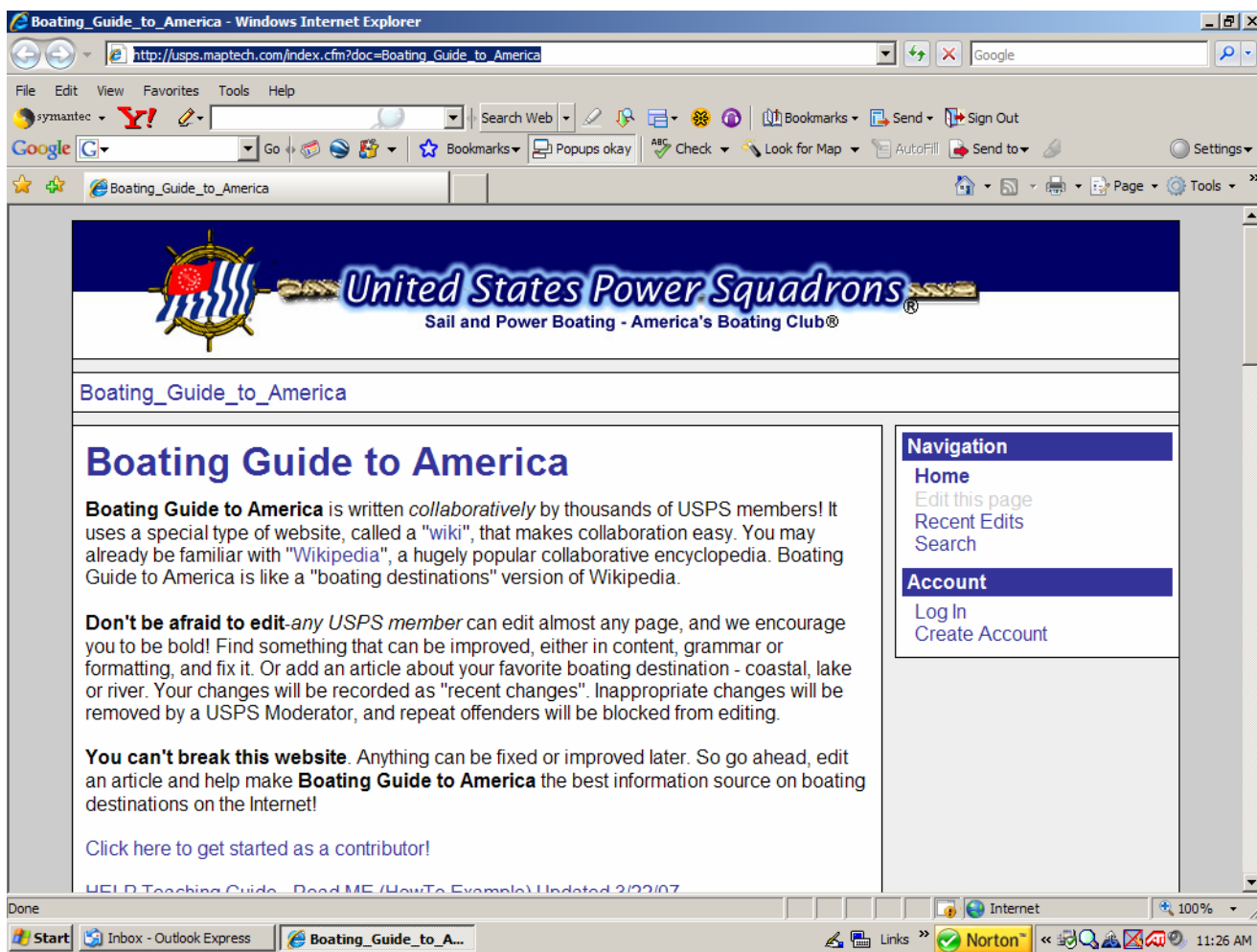
**V-President, Betty Auchter did a great job with the April meeting, as Fred and I were out of town.**

## CO-OP Charting Report Lt. Robert W. Schaefer, P

As Chairman of the Cocoa Beach Power Squadron's CO-OP Charting Committee, I invite each and every member to become involved in some capacity. Although National has done away with the program of locating geodetic markers, there are numerous other programs CO-OP Charting does. Last year, P/C Duane Balkema, AP, received an award primarily associated with the reporting of marker problems on the water or uncharted navigation obstructions. P/C Al Pappas, SN, P/C Sandy Schoonmaker, SN, and Lt/C Rick Schoonmaker, SN, each completed Marina Reports. The marina can be anywhere you find them in your travels by boat or car. I can furnish interested members with the form and do the reports, and train those members as to having the know-how. A more involved aspect is the Depth Wiz program involving checking depths shown on charts. Ernst Hoffman of the Banana River Sail & Power Squadron, whom is my district CO-OP Charting co-chairman, has a team already working this program, and is more than willing to do Depth Wiz work in our area and train members as well. Our Squadron has adopted Chart 11476 and is responsible for keeping it up by checking all markers and information shown on the chart. This can be a group or team effort between the Squadron's..

A "New" program created in cooperation with Maptech, identified as the Boating Guide to America, is something you can do at home and does not require any boating activity. Please refer to the following Web-Site. It is a compilation of activity completed in several sections of a given city and its marine connections. For instance, see Florida and Cocoa Beach , as an example of what I started researching in Cocoa Beach. Any city or town can be initiated and edited if that is your area of focus/interest.

# Play Nice

5 UNWRITTEN RULES OF BOATING THAT SHOULD BE CARVED IN STONE.

## STUMBLER ON A POD OF FISH FEEDING

I frenetically on the water's surface. I positioned the boat alongside the bust, killed the engine, and stepped to the bow. Just as I cocked the rod ready to cast into the boiling water, a guy in another boat trolled right through it, dragging his umbrella rig over the fray and putting every single fish down for the duration. He looked at me and waved as he trolled past, smiling until I shouted at the top of my lungs the politically incorrect version of “YOU IDIOT!”

What crime did this guy unknowingly commit against boating humanity? He violated one of the unwritten rules of the water: Thou Shalt Not Drive Over Feeding Fish. This incident made me realize that while boaters can get schooled ad nauseam on the formal rules of navigation—from the Coast Guard, Power Squadron classes, state-sponsored boater's education, and *Chapman's*—when it comes to the informal ones, they're on their own. Here, then, are four more unwritten rules that every boater should heed.

## Thou Shalt Not Congest the Boat Ramp

If you're one of those guys who backs his boat down, then stops to undo the straps, put in the plug, and run back to the truck to get the cooler, fishing rods, and whatever, know this: The boaters waiting behind you are not amused. You're worse than the people in the lunch line who wait until they get to the counter before finally looking at the menu. Prepare every aspect of your boat before you approach the ramp, then unload quickly and get your tow vehicle parked and out of the way.

## Thou Shalt Help People at the Dock

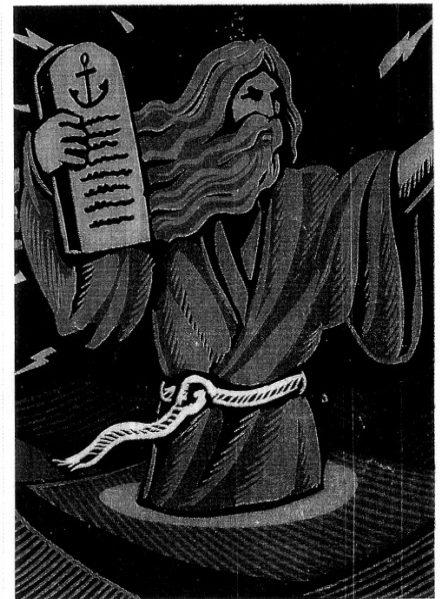
Some boaters aren't the most adept at handling their boats around docks. It's one of those intimidating situations that drive people away. So when you see a guy trying to bring his boat side-to-a tight docking space, and he can't quite make it happen, don't stand there like a spectator watching a golfer choke on the 18th green. Give the guy a hand. Offer to catch his lines and help pull him safely into the spot. Eventually he'll have to learn how to squeeze in there on his own, but until then give the guy a break. The owners of the boats fore and aft of him will thank you, too. (Note: If said boater happens to be a jerk and cuts you or anyone else off to get that spot first, the above rule doesn't apply.)

## Thou Shalt Not Anchor Too Close to Me

Some people just don't get the concept of personal space. Some of these people own boats. They're the ones who anchor right next to me when I've set up for fishing, or crowd me away from working a spot that I discovered. Even if I'm anchored and just chilling with my crew listening to music, I'm not looking for another boatload of new friends. As a general rule, leave enough space so that the boat next to you has room to swing around its anchor with the tide. Try to leave more if you can.

## Thou Shalt Not Circle Me on a Waterbike

Most bikers are pretty cool, but a boisterous few—like punk snowboarders terrorizing a ski hill—give the sport a bad vibe. Don't be one of those and circle dangerously close to my boat while underway. I may not be able to stop in time if you fall off. Or you may force me to rapidly change course, which puts my crew in danger. And if I'm on a flat setting up to cast to spooky fish, don't come roar-



ing out of the channel and blast by me just to see what I'm doing. In the Florida Keys, I'm pretty sure you could be shot for this and no one would press charges. (There's another unwritten rule for you.)

There's one common theme to these fine rules that every boater should learn and learn well: Play nice, and we'll all get along. †

## ANNOUNCING THE USPS UNIVERSITY

In the past year, USPS has undertaken several new education initiatives by creating the USPS University. This new concept includes several new educational venues that are geared toward enrolling new members, as well as creating new opportunities for current members.

The organization is announcing a series of Two-Hour Seminars that will be taught to both the current members as well as to the public. Currently four seminars are available: “How to Use a Chart”; “Using GPS”; “Using VHF& VHF/DSC Marine Radio”; and “Onboard Weather Forecasting”. Several more of these seminars are planned and will be applied to the acquisition of a Boat Operator Certificate.

Being endorsed by the marine industry and the US Coast Guard Office of Boating Safety, these internationally recognized Certificates are geared to the recreational boater who wishes to illustrate their boating proficiency. There will be four levels of Certification, each building off the successful completion of the others. The four categories are: Inland Navigator; Coastal Navigator; Advanced Coastal Navigator; Offshore Navigator.

Each category will require the completion of selected courses from the current core of Advanced Grades and Elective Courses as well as a series of the two-hour seminars. In addition, the candidate will be required to exhibit proficiency in operating a boat of the size and type in which they are applying.

At this time, Regional on-the-water certifiers are being identified and will be trained by National. The certifiers will be individuals with both on the water experience, as well as holding the rank of SN or the rank of AP with all electives completed. Any member interested in being involved in this is encouraged to contact the District Education Officer, D/Lt/C Linda Trent Legg, SN, at [Legg-sofFla@earthlink.net](mailto:Legg-sofFla@earthlink.net).

The first level of certification, Inland Navigator, will soon be available. Watch for up-dates in the *Ensign*.

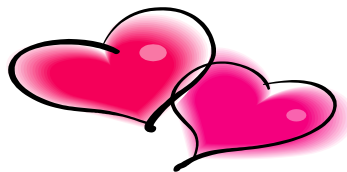

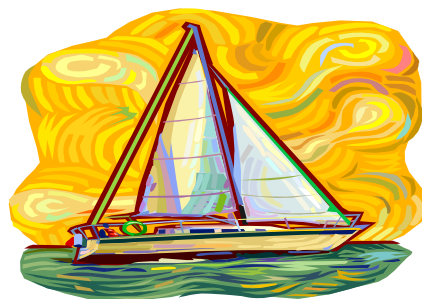
## TOP-10 MYTHS OF LIGHTNING SAFETY

1. **MYTH:** Lightning Never Strikes The Same Place Twice  
**TRUTH:** Lightning often strikes the same place repeatedly, especially if it's a tall isolated object. The Empire State Building used to be used as a lightning laboratory, since it is hit nearly 25 times a year. Place prone to lightning are places to avoid when thunderstorms are nearby!
2. **MYTH:** If It's Not Raining, Or If Clouds Aren't Overhead, I'm Safe From Lightning  
**TRUTH:** Lightning often strikes more than three miles from the thunderstorm, far outside the rain or even the thunderstorm cloud. 'Bolts From The Blue', though infrequent, can strike 10-15 Miles from the thunderstorm. Anvil lightning can strike the ground over 50 Miles from the thunderstorm, under extreme conditions. Lightning in clouds has traveled over 100 miles from the thunderstorm.
3. **MYTH:** Rubber Tires Protect You From Lightning In A Car By Insulating You From The Ground  
**TRUTH:** Lightning laughs at two inches of rubber! Most cars are reasonably safe from lightning. But it's the metal roof and metal sides that protect you, not the rubber tires. Thus convertibles, motorcycles, bicycles, open shelled outdoor vehicles, and cars with plastic or fiberglass shells offer no lightning protection. But closed cockpits with metal roof and sides are safer than going outside. And don't even ask about sneakers! ☺
4. **MYTH:** A Lightning Victim Is Electrified. If You Touch Them, You'll Be Electrocuted.  
**TRUTH:** The human body doesn't store electricity. It is perfectly safe to touch a lightning victim to give them first aid. This is the most chilling of lightning myths. Imagine someone dying needlessly, for want of simple CPR or mouth-to-mouth resuscitation, when their chances of survival was ~90%!
5. **MYTH:** If Outside In A Thunderstorm, Go Under A Tree To Stay Dry  
**TRUTH:** Being underneath trees is the third leading activity for lightning casualties in FL – enough said?!
6. **MYTH:** I'm In A House, I'm Safe From Lightning  
**TRUTH:** While a house is a good place for lightning safety, just going inside isn't enough. You must avoid any conducting path leading outside, such as corded telephones, plumbing, electrical appliances, wires, TV cables, metal doors or window frames, etc. Don't stand near a window to watch the lightning. An inside room is generally best.
7. **MYTH:** When Playing Sports And Thunderstorms Threaten, It's Okay To Finish The Game Before Seeking Shelter  
**TRUTH:** Sports is the activity with the fastest rising rate of lightning casualties. No game is worth death or life-long severe injury. All people associated with sports should have a lightning safety plan and stick to it strictly. Seek proper shelter immediately when lightning threatens.
8. **MYTH:** Structures With Metal, Or Metal On The Body (Jewelry, Watches, Glasses, Backpacks, Etc.), Attract Lightning  
**TRUTH:** Height, pointiness, and isolation are the dominant factors controlling where a lightning bolt will strike. The presence of metal makes virtually no difference on where lightning strikes. Mountains are made of stone, but receive many strikes each year. When lightning threatens, take proper protective action immediately. Don't waste time shedding metal off your body, or seeking shelter under inadequate structures. But while metal doesn't attract lightning, touching or being near long metal objects (fences, railings, bleachers, vehicles, etc.) is still unsafe when thunderstorms are nearby. If lightning does happen to hit it, the metal can conduct the electricity a long distance (even over 100 yards) and still electrocute you.
9. **MYTH:** If Trapped Outside And Lightning Is About To Strike, Lie Flat On The Ground  
**TRUTH:** This advice is decades out of date. Better advice is to use the 'Lightning Crouch': put your feet together, squat low, tuck your head, and cover your ears. Lightning induces electric currents along the top of the ground that can be deadly over 100 Feet away. While lying flat on the ground gets you as low as possible, which is good, it increases your chance of being hit by a ground current, which is bad. The best combination of being low and touching the ground as little as possible is the 'Lightning Crouch'. But the 'Lightning Crouch' should be used only as a last resort. Much better would be to plan outdoor activities around the weather to avoid thunderstorm exposure and to have proper shelter available.



In lightning safety, a "myth" is not as good as a mile ☺. Distance and proper shelter is your best protection from lightning.
